Reports: Library- Had their first case of staff testing positive with Covid-19, put guidelines in place. Coleman library is changed over now part of the same as Pere Marquette. Still need some work on their website. Fire- Coleman switched their bank to Mercantile Bank. MTA- Tony Casali, Road Manager gave is annual report. Gravel Program is still on. Roads -Coleman Rd. has been completed with wedging the sides and a 1.5 inch of overlay on one mile. It looks nice. Leaton Rd. has been Chip Sealed, as has one mile of Vernon. Election- We tested our machines on October 8, election is Nov, 2, 2021Mt. Pleasant School District Bond Issue.
